TERMS AND CONDITONS

General

1. The Junior Leisure Club (JLC - or membership) is open to children (members) aged 5 – 15 years only.
2. Minimum membership period is for 1 month only.
3. All members must complete a registration form giving contact details of parents, carers or guardians. If there are any changes to the contact details for the card holder or direct debit payee, Corby Borough Council must be informed, by contacting, in writing, Corby East Midlands International Pool or Lodge Park Sports Centre or e mailing swimming.pool@corby.gov.uk
4. If you fail to notify us of a change of address, any communications will be deemed to have been received by you 5 days after posting by us.
5. In the event of any disagreement in the interpretation of the facility rules our decision is final.

Fees

1. The monthly membership is paid by direct debit only and costs £12.50 per month. This will be taken from the parent, carer or guardians bank account on the 1st day of each month.
2. If a new member decides to join at anytime during the month, then there will be a pro rata payment to cover that month (matrix fee) up to the end of the first month. Then full payment will then be collected via direct debit on the 1st of the following month.
3. Members will be issued with a loyalty card, which remains the property of Corby Borough Council.
4. If there are any changes in prices for the membership, then all direct debit payees will be given at least 30 days notice, in writing.
5. Hire equipment will be charged at £1.50 for 2 members or £2.50 for up to 4 members. A £5 deposit will be required before the equipment is hired and will be returned to the members once the equipment has been handed back in the same condition that it was given out.
6. There is no cost to members for their first issue of a wrist band, fob or card however, if a replacement is required there will be an additional charge.

Your Obligation

1. To comply with facility rules.
2. To observe in particular all health and safety rules regarding the use of each facility.
3. To use the facility equipment and facilities in accordance with all usage instructions, not to abuse the equipment and facilities, and to

conduct yourself in an orderly manner so as not to interfere with other members use or enjoyment of the facility and its facilities.

Cancelation Policy

1. If you wish to cancel the membership, then you must inform, in writing, the following e mail address, swimming.pool@corby.gov.uk. Termination of membership will cease at the end of that month in which notice has been given, providing the payment run hasn't been carried out already (usually the last week of the month)
2. It is up to the member to cancel your direct debit with your bank.
3. If an activity has been booked a week in advance and the members do not show up and have not cancelled giving at least 24hrs notice, they may be charged for the price of that activity.

Termination by us for breach of membership

1. We may terminate your membership immediately at our absolute discretion if you are in serious breach of this agreement or repeat minor breaches.

Facility Repairs and Maintenance

1. We reserve the right to close the facility for up to 30 days in any one calendar year for the purposes of carrying out repairs, refurbishments and maintenance, whether routine or extraordinary in nature. Should any closure extend beyond 30 days or if the facility is closed for these reasons for more than 30 days in a calendar year, we will refund you a proportionate amount of the subscription fee for the closure period exceeding 30 days.

Liability

1. We and our employees, officers and agents will not be liable in any way for the loss of, or damage to, or theft of property or members or guests or for personal injury to, or death of, any member or guest, except to the extent that such loss, damage or personal injury or death arises from our wilful act, negligence or default.

Privacy Notice

As a Local Authority, Corby Borough Council processes a considerable amount of information, including personal data about the citizens it serves, to allow it to provide services effectively.
